FIRST NOTICE OF ANNUAL MEETING & ELECTION OF DIRECTORS

NOTICE is hereby given that the Annual Meeting of the members of Portside Condominium Homeowners' Association will be held on Saturday, October 19, 2024, at 9:00 am Central Time at the Portside Clubhouse located at 17620 Front Beach Road, Panama City Beach, Florida. At this meeting, the members will elect THREE (3) directors for the 2024-2026 year and conduct the Annual Members Meeting.

Provided with this First Notice of Annual Meeting and Election of Directors is a Candidate Nomination Notice, Candidate Information Sheet, and Voter Authorization Certificate. A Second Notice of Annual Meeting which shall include candidate biographies, proxy, and ballot materials, will be sent to all owners later which will be not less than fourteen (14) days prior to the Annual Meeting. Information will be sent electronically if the Owner agrees.

In accordance with Florida Statutes §718.112(2)(d)(4)(a), A unit owner or other eligible person desiring to be a candidate for the board must give written notice of his or her intent to be a candidate to the association. If you would like to be considered for a Director position and have your name included on the ballot, please submit a Notice of Intent to Run (you may use the enclosed Candidate Nomination Notice – Intent to Run Form) and return it to the Association no later than 5:00 PM CDT on September 9th, 2024 (40 days prior to the Election).

Candidates are also encouraged to complete a Candidate Information Sheet to be included with the Second Notice. For your convenience, we have provided one for you, which meets Florida statutory requirements. You may submit this Candidate Information Sheet or submit one of your choosing, which shall be printed in black ink or typed; and which, in accordance with Florida Statutes §718.112(2)(d)(4)(a) shall not be larger than one page measuring 8.5 x 11 inches. Submission of a Candidate Information Sheet is optional and shall not be required to have your name included on the ballot. Members wishing to include a Candidate Information Sheet with the Second Notice must do so no later than 5:00 PM Central Time on September 14th, 2024(35 days prior to the election).

Under the provisions of the Condominium Act, a person must be eligible to serve on the Board of Directors at the time of the deadline for submitting a notice of intent to run (40 days before the election).

You will not be eligible for Board Membership if any of the following apply:

- 1. In a condominium with more than 10 units if you and a co-owner of your unit would serve on the Board at the same time unless you own more than one unit or there are not enough eligible candidates to fill the vacancies on the board.
- 2. You were a director who was suspended or removed by the Division.
- You are delinquent in the payment of any assessments due to the Association.
- You were convicted of a felony in Florida or convicted of an offense in another jurisdiction that would be considered a felony in Florida (unless your civil rights have been restored for a period of no less than five (5) years as of the date of the election); and/or,
- 5. You are a director charged with a felony theft or embezzlement offense involving the Association's funds or property and such criminal charge is pending.

NOTE: If separately submitted after a candidate's written nomination is delivered, then the Candidate Information Sheet must be returned not later than September 14, 2024 (35 days before the election)
